- Which Coaching qualifications if any do your instructors hold?

- Has your association or any clubs in your association previously been members of the S.K.G.B.? If so please supply past history.

- Have any clubs in your association been previously members of any other association that is currently members of the S.K.G.B.?

- Will all your instructor/coaches be prepared to meet the coaching requirements of the S.K.G.B. and have an Enhanced Scottish Criminal Records Office check carried out by the S.K.G.B.?

- Will your association and its affiliated clubs implement all S.K.G.B. policies?
